# **Description - Jacket**

Concealed metal zip on jackets

- Over locked stitching shoulders and arm holes
- Left breast pocket with pen division and V-flap with concealed press stud
- Dromex sidewinder on left breast pocket
- Laid pockets
- Dromex wash care labels sewn into neck
- Reinforced bar tacks
- Sleeve hem 1.5cm
- Jacket bottom hem 1.5cm
- 50mm Lime silver lime reflective webbing tape.

### **Description - Pants**

- Laid pockets on pants
- Concealed metal zip
- Triple stitched in-leg and back rise
- Dromex sidewinder label sewn into back pocket
- Reinforced bar tacks
- Leg hem 1.5cm
- 50mm Lime silver lime reflective webbing tape.

# Specifications

This garment is suitable for use in warehouses, workshops, gardening, construction, janitorial and other low-hazard environments. Not suitable for use in environments that require protection from acid, flame, petrochemical or mining risks. In the event that this suit comes into contact with any hazardous substances or elements, remove immediately and follow disposal procedures.

There is no SANS specification for 80/20 Conti Suits therefore no testing has been performed on this garment.




### Storage & Obsolescence

These garments if stored correctly will have a shelf life of 5 years. Disposal of all contaminated personnel protective garments should be in the correct manner as per the local, statutory and recommended best practice as the garments could be contaminated.



### **Cleaning & Maintenance**

Dromex garments can be cleaned by home cleaning or commercial laundering provided all the recommended conditions and setting are adhered to. If home procedures do not remove contaminants then drycleaning is recommended. Do not overload home laundry equipment. Our recommended cleaning for these garments are:



The following suggestions will keep your garment looking neat, attractive and safe:

Pre-treat greasy stains and collar and cuff lines or wash the garment in hot water with a light dry cleaning solvent. Do not use Hypochlorite bleach or detergents containing Hypochlorite bleach.

Chlorine bleach may cause fading and reduce fabric strength. The washing procedure must include a thorough rinsing to remove any wetting agents followed by a cool ironing to regenerate the finish effect.

# Disposal

All industrial waste should be disposed of correctly according to local regulations and good disposal practice. Workwear should be disposed of considering the hazardous substance they were used for as well as the material they are made up of. Please consider recycling.
